#### FINANCIAL ASSISTANCE POLICY & PROCESS

### FINANCIAL ASSISTANCE PHILOSOPHY

The Children's School is committed to creating a socio-economically diverse and financially accessible education. We are committed to expanding the reach of our financial assistance as the school continues to grow.

The Children's School's need-based financial assistance program provides financial aid to qualified families. This program is primarily financed by general fund revenues with a much smaller percentage from generous donor gifts.

The Children's School believes that parents have an obligation to pay the educational expenses of their children. Because financial assistance is based on a family's ability to meet the cost of education, we require financial data from both parents. In the case of parents separated, divorced, or never married, both parents are required to fully complete the financial assistance application. It is expected that both parents contribute to the cost of the student's tuition. The Financial Assistance Committee will not be bound by the assertion that one parent disclaims responsibility for educational expenses.

#### FINANCIAL ASSISTANCE COMMITTEE

The Financial Assistance Committee is chaired by the Head of School and includes the Director of Finance and the Director of Admissions. The Financial Assistance Committee reviews the financial needs of applicants and allocates the limited financial assistance resources among the applicants. All information submitted is kept in the strictest confidence.

#### FINANCIAL ASSISTANCE COMMITTEE GUIDELINES

In the evaluation of financial assistance applications and the granting of awards, the following serves as the governing guidelines for the financial assistance process:

- Financial assistance decisions are made independently from admissions decisions.
- Kindergarten through eighth grade families may apply for financial assistance.
- A family's financial need is the basis for all financial assistance awards. The Children's School does not offer academic, arts or athletic scholarships.
- In an effort to provide an objective and consistent evaluation of applications, The Children's School uses the services of *School and Student Services (SSS) by Community Brands*, in collaboration with the National Association of Independent Schools. Each

applicant family is required to complete a Parents' Financial Statement (PFS). The PFS documents family income, expenses, assets, liabilities, and other factors that might influence a family's ability to pay tuition. Using the information from the PFS, SSS computes an estimated family contribution for tuition. The SSS computation is only one factor considered by the Financial Assistance Committee in setting grants.

- Financial assistance is awarded with priority to returning students in the elementary and middle years programs whose applications are submitted by the deadline.
- Tuition accounts for currently enrolled students must be in good standing to receive financial assistance. All families are required to meet payment schedules under the terms of the enrollment agreement. Failure to do so may result in dismissal.
- To be considered for financial assistance, families must apply for financial assistance every year. Families who currently receive financial assistance must reapply each year.
- The Children's School believes that every family, regardless of economic standing, should demonstrate a commitment to their child's education by making some contribution; therefore a maximum award of 50% of tuition may be offered, based upon need. Exceptions to this procedure must be approved in writing by the Head of School.
- Financial assistance is offered without regard to race, gender, national or ethnic origin, religion or sexual orientation.
- If The Children's School determines that any information was withheld or falsified during the application process, it reserves the right to withdraw any offer or award of financial assistance.
- If the financial assistance awarded does not meet the needs of the family, the monthly payment plan may be of assistance. Parents paying tuition under the monthly payment plan and receiving financial assistance must allow the school to automatically withdraw the monthly tuition payment from their bank account. Exceptions to this procedure must be approved in writing by the Head of School.

#### FINANCIAL ASSISTANCE PROCESS

Families that believe they may qualify for financial assistance are encouraged to apply. Returning families must complete the steps below by **December 16, 2022.** New families must complete the steps below by **February 1,2023**:

#### 1. Complete and submit online

- A copy of the Parents' Financial Statement (PFS) submitted to the SSS
- A copy of your 2021 Federal Income Tax Return, including all supporting schedules
- A copy of your 2021 K-1s, W2s and 1099s (by February 1, 2023 for both returning and new families)
- A copy of your 2022 Federal Income Tax Return, including all supporting schedules, K-1s, W2s and 1099s (by April 15,2023 for both returning and new families)
- If applicable, a signed copy of IRS Form 4506

#### FINANCIAL ASSISTANCE DECISIONS

Grants are based on numerous factors including the SSS recommendation, financial data submitted by the family, and any extenuating circumstances detailed on the *Financial Assistance Program Application*. Decision notifications and deadlines for the 2023-2024 school year are listed below:

- Preliminary financial assistance descisions for returning families will be emailed on January 27, 2023.
- Acceptance of these grants must be made by February 10, 2023.
- Grant decisions to new families will be emailed on March 10, 2023. Acceptance of these grants must be made by March 24, 2023.
- All financial assistance grants made before receiving the 2022 tax return or other required information are contingent upon receipt and review by the Financial Assistance Committee.
